2. A copy of the revised draft valuation list is available at the Council Offices for inspection for a period of thirty (30) days from the date of this publication.
3. A person may take a copy (ies) and extract(s) from the revised draft valuation list upon payment of the relevant fee.
4. Any person who is aggrieved by:-
  - i. The inclusion of any rateable property in the draft valuation list; or
  - ii. Any value ascribed in the revised draft valuation list to a rateable property or;
  - iii. Any other statement made or omitted to be made in the revised draft valuation list with respect to any rateable property; or
  - iv. In the case of a building or portion of a building occupied in parts, by the valuation in the Revised draft valuation list of that building or portion of a building as a single rateable property, may within **thirty (30) days** of publication of this notice, serve notice of objection upon the Local Government to the draft valuation list in relation to the rateable property.

**IMPORTANT:** A property shall not be entitled to be heard by the Valuation Court unless he or she had lodged a notice of objection within the stipulated time.
